### **PUBLIC HEARING:**

 Ms. Camp opened Public Hearing at 7:10 PM on Ordinance 1-2020 amending Section 202 of the West Nantmeal Township Zoning Ordinance of 2010 to add a definition for "Farm Related School". Ms. Camp stated Proof of Publication in the Daily Local News on March 23 and March 20, 2020; correspondence to the Chester County Law Library and Chester County Planning Commission; and correspondence from the Chester County Planning Commission would be provided. This ordinance was also reviewed by the West Nantmeal Township Planning Commission. This ordinance would allow a farm related school in the R1 District and adds Section 755 to adopt specific regulations regarding a farm related school. No public comment was presented.

<u>Motion:</u> Mr. Beam made the motion to adopt Ordinance 1-2020 to amend Section 202 of the West Nantmeal Township Zoning Ordinance of 2010 to add a definition for "Farm Related School" in the R1 District and add Section 755 to adopt specific regulations regarding a farm related school and was seconded by Mr. Daniel. Motion carried 3-0. Public Hearing was closed by Ms. Camp at 7:15 PM

### Engineering:

- Road bids were opened on April 10 but references still need to be completed which will be forwarded to the Board upon completion. Mr. Kologie advised that Dan Malloy Paving had been acquired by Advanced Pavement Group and they were included in the bidding process. Bid award is tabled until the May meeting.
- Yoder Road culvert repair permit has been submitted to DEP as it is required before the repair goes out for bid. The DEP permit is good for one year once it is issued.

### Solicitor's Report:

• Ms. Camp discussed the Ratification of the Declaration of Emergency for West Nantmeal Township which would allow the Board of Supervisors to declare and emergency outside of a scheduled meeting. There was discussion regarding PEMA requirements, and it was decided to sign the Declaration with an indefinite date until further order of the Board.

<u>Motion</u>: Mr. Beam made the motion to adopt Resolution 2020-1 which would ratify the Declaration of Emergency pertaining to Coronavirus COVID-19 and was seconded by Mr. Elston. Motion carried 3-0.

 <u>Zoning Hearing</u> – Ms. Camp recommended another 30-day extension for Emmanuel Stoltzfus' Zoning Hearing due to the required closing of the township building to the public. This extension would allow the West Nantmeal Township Planning Commission to meet and review the information in May and provide recommendations to the Board of Supervisors at the June meeting.
