- Road Paving Bids 5 bids were received for the repairs to the South side of Pumpkin Hill Road.

<u>Motion</u>: Mr. Elston made a motion to accept the bid from Construction Masters Services, LLC, in the amount of \$101,333.90 for the repairs to the south side of Pumpkin Hill Road and was seconded by Mr. Beam. Motion carried 3-0.

• Plans for potential Bollinger Road parking expansion were presented for Board review. Will move forward with grant applications in the fall.

Zoning Report:

- Killian Road property maintenance issue has improved though the unregistered, inoperable vehicles remain on the property. Another citation will occur if they are not removed by June 1.
- Reviewed other complaints and violation letters will be issued. Discussed updating the property maintenance ordinance.
- Mr. Elston discussed Solar Farms and the impact on preserved farmland. AirBnB and short-term rentals are another concern and Ms. Camp will develop a plan to address the issue.
