- Lots 1, 4, and 5 will be off the cul-de-sac
- Mr. Brower suggested that a Homeowners Association (HOA) would be necessary for property and road maintenance.
- Due to plan changes, it will need to go back through Conditional Use.

### Hammell-O'Donnell Business Park at 161 Column Drive.

Mr. Sean O'Donnell discussed the location of an emergency access road that was recommended at the July meeting. At present the access road will be located between lots 2 and 3. Mr. Moyer suggested placement along the property line for simplicity.
