BOARD OF SUPERVISORS MINUTES JUNE 11, 2012

Chairman Elston called the Regular Meeting of the West Nantmeal Township Board of Supervisor, held at the township building, to order at 7:00 P.M.

Camp said there were some minor changes to the agreement that was approved last month and will contact Mr. Good (DiLibero's solicitor) but if the DiLibero's agreed the agreement could be signed and forward to them after the changes were made. The DiLibero's did agree and Ms. Camp will see to the changes.

<u>Terry Walsh, 11 Fairview Rd, Honey Brook, PA:</u> Mr. Walsh was here regarding the Enforcement Notice that he received. Mr. Walsh rents the property from Mr. James Ford, who was also here this evening. After a lengthy discussion it was decided that it is up to Mr. Walsh and Mr. Ford to:

- Document when both stables were installed
- Remove the fill (they were given until mid August)
- Regarding the Tree Harvesting. No additional trees can be removed.

Dr. Morris Kauffman, Craig Arbaugh and Tom Marks, All residents of Bollinger Road, were here regarding excessive noise and heavy trucks using this road. The Bollinger Bridge located on this road can't take some of the weight of these tri-axels using this country road. Some of the suggestions were; a lower speed limit, speed bumps,

weight limit for the bridge. Our solicitor will contact the county (Sandy Martin) to discuss the options regarding the bridge.

Our engineer pointed out that to lower the speed limit a traffic study would have to be done and to post the bridge a engineer study would have to be completed. Even if these things were done then there is a problem of enforcement.

Another problem is the off road vehicles illegally using the road and disturbing the peace. Ms. Camp felt that a stern letter should be sent by the zoning officer and they were advised to contact the state police when this happened again.

Guns: There is target practice happening on a neighborhood property. There is little that can be done if they are using safe practices and noise isn't constant.

Reports:

Frank Newhams, Zoning Officer, gave the Zoning Report.

- Reviewed the permits issued for the month
- Citation for Killian Road will be issued the next day
- We have not heard from the settlement company for the Killian Road, Micro Mound. Ms. Camp suggested that Mr. Newhams contact the owner to find out who the settlement company is so they can be advised that the escrow is needed. We are presently with holding the U&O permit until the money is received.

Road Report: Given by Mr. Beam, Road Master and Mr. Sautner, Road Manager. Most of the work this month was with mowing the roads and dealing with the Road Bid for the Isabella Road project.

Mr. Sautner showed the board a roofing tile that blew off the township building and Chairman Elston suggested that we put a new roof in the budget for next year.
