This was seconded by Mr. Beam. Motion carried unanimously.

The secretary will contact Yoder's for our annual Appreciation Dinner. Two dates have been selected. March 23rd or 30th.

Craig Stoltzfus: Mr. Stoltzfus is seeking a waiver from our Stormwater requirements. The subject came up last month but the Board felt they needed additional information. Mr. Stoltzfus came to the meeting this evening to explain that he wants to take any run off he may have and use it for irrigation. The board felt that was fine as long as a certain crop was planted if the crop changes it could be a problem. Different measures for stormwater were discussed. Mr. Stoltzfus wants to talk it over with his engineer. Issue tabled.

Expenses for the 2013 Budget were reviewed. The secretary will have all the budgets, Revenue, Expenses, and other departments for a final review by the November meeting.

Correspondence was reviewed.

Bills were paid as listed on a Motion made by Mr. Mast, seconded by Mr. Beam. Motion carried unanimously.
