<u>Randy Lammey Jr:</u> Presented a request for the township to analyze and reconsider the engineering fees for his stormwater review. Mr. Elston asked Mr. Kulakowsky to address the concern and respond by the end of the week to Mr. Lammey and the Board of Supervisors.

REPORTS:

Engineering: Mr. Kulakowsky gave the monthly report and it will be on file in the township office.

- <u>Bollinger Road Bridge</u> Work is limited to the period of November 1 through February 28 due to trout restocking and the bog turtle hibernation period. Margaret Sherman, PennDot Consultant, has notified the township and Cedarville that weight limit signs must be posted for the bridge. The bridge may be rated for a higher capacity after being repaired.
- <u>2018 Road Program Presented an estimate of cost of \$314,893.75</u> for the paving of Bollinger and Isabella Roads and repairing Killian Road. This estimate will reviewed again at the January meeting and Mr. Kulakowsky will prepare a bid package if approved.

Zoning Report: Danielle Stoltzfus, gave the monthly report and it will be on file in the township office.

- Confirmed that deer fencing at the Hammell-O'Donnell properties is considered agricultural.
- Gave a report on a property located on Lammey Road in response to complaints by neighbors. A letter will be sent to the homeowner addressing the violations.

Solicitor's Report:

- Discussed House Bill 1620 regarding cell towers located within the township right of way. Ms. Camp will bring an example to the January meeting.
- Ms. Camp will edit the Park ordinance as per the Parks and Recreation Committees recommendation. The ordinance will be advertised and ready for approval at the December 26, 2017 meeting.

Roads:

• Snow management went well during the first winter event with Craig Stoltzfus providing assistance. David Mast will be a secondary assistant when needed.

- Mr. Daniel, Mr. Beam, and Mr. Cochran toured the park to determine where repairs and/or maintenance were needed.
- Lee King will be removing several trees including stump grinding on December 26, 2017 at an estimated cost of \$2200.00.
- Mr. Beam and Mr. Cochran have been meeting weekly to prioritize necessary work.

Parks and Recreation:

November 21 meeting discussed the Park ordinance and Community Day. The Committee
decided that if there is an annual event it should include a 5K/10K Race along with another
event such as a car show or music event.
