PUBLIC HEARING:

• Ms. Venzie opened Public Hearing #1 on Resolution 2018-5 regarding three parcels to be included in the existing Agricultural Security Area (ASA). She presented exhibits: Notice to adjacent property owners; October 22, 2018 correspondence to Craig Arbaugh, parcel 23-4-16.1; October 23, 2018 correspondence to Susan Springsteen, parcel 23-6-14.1 and 23-6-14.1A; Evidence of posting on properties; November 14, 2018 correspondence to West Nantmeal Planning Commission and Chester County Planning Commission; Proof of Publication in the Daily Local News on November 30, 2018; and Correspondence from the Chester County Planning Commission recommending these properties to be included in the ASA. Questions from the audience were answered by Ms. Venzie pertaining to the requirements to be included in the ASA.

<u>Motion:</u> Mr. Beam made the motion to adopt Resolution 2018-5 to authorize the proposed additions of parcels 23-4-16.1, 23-6-14.1, and 23-6-14.1A to the existing West Nantmeal Township Agricultural Security Area (ASA) and was seconded by Mr. Daniel. Motion carried 3-0.

 Ms. Venzie opened Public Hearing #2 on Ordinance 3-2018 to Regulate the Use of Consumer Fireworks, Providing for the Granting of Permits for the Use of Display Fireworks, Prescribing Safeguards concerning Same, Prohibiting the Use of Display Fireworks without Obtaining a Permit and Prescribing Penalties for Violations. Three exhibits were presented: Proof of publication in the Daily Local News on November 30, 2018; December 4, 2018 letter to the Chester County Law Library; December 4, 2018 letter to the Daily Local News

<u>Motion:</u> Mr. Beam made the motion to adopt Ordinance 3-2018 to Regulate the Use of Consumer Fireworks, Providing for the Granting of Permits for the Use of Display Fireworks, Prescribing Safeguards concerning Same, Prohibiting the Use of Display Fireworks without Obtaining a Permit and Prescribing Penalties for Violations and was seconded by Mr. Daniel. Motion carried 3-0.

Public Hearings were closed by Ms. Venzie at 7:38 PM

AUDIENCE:

 Mariana Collins regarding Wyebrook Farm – Ms. Collins presented a proposal for planned parking and addressing DEP requirements. Mr. Flinchbaugh explained that further permits will be required to proceed on proposed project plans. Ms. Collins expressed concerns regarding zoning changes required to allow more employees.

REPORTS:

Engineering: Mr. Flinchbaugh gave the monthly report and it will be on file in the township office.

<u>Bollinger Road Bridge</u> – Repairs are completed for the necessary repair work and he provided a
change order for \$6,437.50 for additional repointing of stone masonry that was necessary to
complete the project. Total payment to Bill Anskis Company for the project is now \$47,025.90
and Cedarville Engineering recommended payment.

December 10, 2018

Hammell-O'Donnell Business Park: Resubmission of land development plan is required and will
need to be presented to the Planning Commission for preliminary approval. Further certification
from Aqua PA and Public Utility Commission approval are also needed.

Zoning Report: Ms. Stoltzfus gave the monthly report and it will be on file in the township office.

- 277 Killian Road: An inspection is necessary prior to the court hearing.
- 1026 N Manor Road: Some remediation has been completed with the exception of an unregistered vehicle that remains on the property. The property owner has not responded to the Conservation District regarding a manure management plan and has not responded to Ms. Stoltzfus. Citation was issued at District Court.
- <u>2989 Creek Road:</u> Met with the property owners regarding a violation in renting a cottage on the property. The prior zoning variance has become null and void and the present owners wish to apply for a new zoning variance.
- <u>Sunoco Pipeline</u>: Requested to close the permits for pipeline work in the township. Chester County Conservation District, Department of Environmental Protection and PennDot need to agree with the completed work before the permits may be closed. Mr. Elston asked that Ms. Stoltzfus provide a list of hours for this project. It was also decided that the permits will not be closed until all open invoices are paid in full. Yoder and Hedge Roads still need repairs to the road. A restoration inspection must also be completed by Cedarville Engineering.

Solicitor's Report:

• Public hearings were completed prior to addressing the audience.

Planning Commission:

• <u>Agricultural Security Area (ASA) additions:</u> reviewed the proposed addition of parcels 23-4-16.1. 23-6-14.1, and 23-6-14.1A and recommended inclusion in the existing township ASA.

Roads:

- Mr. Beam provided information on calibrating the salt spreader to improve efficiency.
- Drains have been cleaned and road equipment has been prepared for winter months.
- A quote was received from E.M. Kutz for the installation of plow lights at a cost of \$1064.10 and on spot chains, \$209.00 for each side, for the township truck.

Motion: Mr. Elston made the motion to have E.M. Kutz install new plow lights and on spot chains for the township truck and was seconded by Mr. Daniel. Motion carried 3-0.

• A 2019 Ford F550 XL 4 wheel truck with plow and salt spreader attachments has been ordered from Sunbury Ford with delivery expected in March, 2019.

Parks and Recreation:

- Still negotiating with the company who provided the gazebo regarding necessary roof repairs.
- Next meeting will be early 2019.

• <u>DigEntGrp:</u> Mr. Michael Kerr submitted a 90 Day extension for his subdivision and planning module timeline which begins December 11, 2018.
