 Ms. Venzie opened the hearing for <u>Ordinance 1-2021</u> which amends the West Nantmeal Township Zoning Ordinance of 2010 by Amending the Use Provisions of Sections 402, 405 and 406 to Remove Kennels and Animal Shelters as a Use Allowed by Special Exception in the R-1 District and to Allow Kennels and Animal shelters in the C-1 and I-1 Zoning Districts: to amend Matrix Chart 4 and 5 to Add Utility and Dimensional Requirements for Kennels and Animal Shelters in the C-1 and I-1 zoning Districts; and to Amend Section 731 Which Adopts Regulations for Kennels and Animal Shelters.
