- Yoder Road culvert shop drawings are in process with a projected April start date.
- Ford-Rigg Pumpkin Hill Sub-division no response for request for extension
 <u>Motion</u>: Mr. Daniel made a motion to deny the Ford-Rigg Pumpkin Hill Subdivision Plan unless a grant of extension is received by December 30, 2024 and was seconded by Mr. Beam. Motion carried 3-0.

Zoning Report:

No scheduled hearings and following up on zoning compliance issues.

Solicitor's Report: no report

Planning Commission:

- Hammell-O'Donnell requested no sidewalks or street lighting for the Business Park.
- Comprehensive Plan survey reviewed results and will move forward to the next stage which involves key personnel. Mr. Elston asked that solar be addressed in the plan.

Roads:

- Continued road maintenance including clearing drainage areas
- Township roads that are maintained by PennDOT need to be defined for residents.
- "Children at Play" signs will be ordered for Wyebrook Road.

Parks and Recreation:

- Tree Lighting, December 6 was well attended with 80 -100 people.
- An updated sign was installed for the Recreation area by Marsh Creek Signs.

Historic:

Rob Brown presented year-to-date finances including income and expenses. He also gave a
recap of Historical Commission events throughout 2025 which included working on the Lewis
Mills Historic District, information programs, two newsletters and a Township school reunion.

EMS:

- Provided support for the October 19th fire on Isabella Road
- The burn ban for Chester County was removed.
- Pipeline exercise on December 5 went well for all involved agencies.
