- 9. <u>June 19<sup>th</sup> storm event PennDot was non-responsive for tree removal on Chestnut Tree Road.</u>
  Mr. Elston will contact Paul Friel's office to discuss the situation.
- 10. <u>Farming lease</u> The current lease expires December 31 and will need to be advertised. An option to extend with mutual consent will be added to the lease contract.
