

Board of Supervisors Meeting **December 8, 2025**

Opening: Chair Elston opened the regular scheduled meeting on Monday, December 8, 2025, at 7:00 P.M. at the West Nantmeal Township Building.

Roll call was taken, and present were supervisors: Gary C. Elston, Nelson R. Beam, Frank V. Daniel, Jr, Craig Kologie, Zoning Officer, Kristin Camp, Solicitor, and Amanda Sundquist, Solicitor.

Public Comment: Chair Elston called for public comment on tonight's agenda which was available at the meeting and posted on the Township Building and website; No public comment was received.

AUDIENCE:

- Trooper Greenert from the Embreeville Barracks was in attendance and discussed the “Paul Miller Law” which prohibits the use of hand-held devices while driving; encouraged everyone to watch for fraud/scams; child car seat installation events. Also stated that each trooper covers a large territory during patrol times due to limited staffing. Mr. Elston thanked Trooper Greenert for the service that Embreeville Barracks provides to the Township.

Engineering:

- Yoder Road widening to 18’, patching, and base repair with double seal coat – approximately \$287,000.00.
- Contractor has not provided as-built plans for the Yoder Road culvert. Still holding final payment.

Zoning Report:

- Continuing to work through enforcement and zoning compliance issues.

Solicitor’s Report: No report

Planning Commission:

- Reviewed the draft anaerobic digester ordinance and gave recommendations.
- Hammell-O’Donnell Business Park Lot 4 plan will be discussed at the next meeting.
- Comprehensive plan is in final stages. Ms. Camp will provide the required procedures to adopt the plan.

Roads:

- The new Mack truck has been evaluated and used for salting in the last snow event.
- Waiting for confirmation from Chester County regarding Goodfellow Road repairs.
- Drainage ditch cleaning and continued road maintenance are continuing.

Parks and Recreation:

- Tree Lighting on December 5 was a well-attended and successful event.

- Committee members will review locations in the park for the possible placement of memorial benches and present for Board approval.
- Recommending a wireless sound system for Community Day and other park events.

Historic: No report

EMS:

- Secured a grant for 20 AEDs for Twin Valley Fire Company and Honey Brook-Elverson EMS.

NEW BUSINESS:

1. Twin Valley Fire Department 2026 contract – Requested 2026 contribution is \$31,801.00 to provide coverage to West Nantmeal Township.

Motion: Mr. Daniel made a motion to approve and sign the 2026 Twin Valley Fire Department contract in the amount of \$31,801.00 and was seconded by Mr. Beam. Motion carried 3-0.

OLD BUSINESS:

2. Anaerobic digester ordinance- Ms. Sundquist discussed both ordinances.
 - Reviewed the ordinance for “The Application and Storage of Food Processing Residuals” which regulates how the digestate is stored and applied. Fine has been increased to \$1000.00 per violation. This ordinance does not have to be approved by Chester County Planning Commission.

Motion: Mr. Beam made a motion to advertise the ordinance for “The Application and Storage of Food Processing Residuals” for adoption at the February 9, 2026 meeting and was seconded by Mr. Daniel. Motion carried 3-0.

- Reviewed the ordinance to “Provide for the Regional Anaerobic Digester Use” with its increased setbacks and 4 possible locations in Limited Industrial Township sites. This is only for agricultural use. Changes were made to Flare height cap, decommissioning , biogas transmission, inspections, and floodplain requirements. The following residents in attendance commented on the proposed ordinance and requested that the setback be increased to 2500’: Skip deGaray, Carrie Elliott, Keith and Tina Grant, Megan Kennedy, Sharon deGaray, Dorothy Rajan, Terry Sautner, Don Gable, Tim Barnes, and Meghan deGaray.

Motion: Mr. Elston made a motion to approve the 2500’ setback for a regional biodigester and was seconded by Mr. Daniel. Motion carried 3-0.

Motion: Mr. Beam made a motion for Ms. Sundquist to make the approved change to the ordinance and send it to Chester County Planning Commission for review and was seconded by Mr. Daniel. Motion carried 3-0.

3. 2026 budget – reviewed budget with changes that were discussed at the November 10 meeting.

Motion: Mr. Beam made a motion to approve and advertise the 2026 budget for approved at the December 29 meeting and was seconded by Mr. Daniel. Motion carried 3-0.

OTHER BUSINESS: Reviewed plan extensions for Lippitt Road Properties and A&J Specialties.

BILLS: The bills to be paid this evening have been reviewed.

Motion: Mr. Beam made the motion to pay the bills and was seconded by Mr. Daniel. Motion carried 3-0.
