NEW BUSINESS

Steven Guthan – 15 Woods Road – Mr. Guthan has filed a Notice of Appeal for a variance for shed location 35' from wetland line, driveway to shed is within 50' of wetland line, and future house would be 35' from the wetland line. The Board of Supervisors asked the Planning Commission to give their recommendation concerning this Notice of Appeal.

PC voted unanimous on this recommendation: PC's recommendation to the Zoning Hearing Board is to consider allowing the shed to remain at the current location.

Kim Levin – Ms. Levin wishes to discuss her possible purchase of Lot 4 of the Jordan Hammell property on Pumpkin Hill Road. She is considering building a 36'X60' 6 stall barn, 4 paddocks, riding rink and a small 44'X44' 2 story house on the 10-acre lot of which 4 acres are wetland. Levin asked how many horses she could have on the property. If there is five net acres, she could have 10 horses on the property. If the barn were constructed first, sewer and water would be required on the property.

OTHER BUSINESS

Brandywine Creek Greenway Municipal Boards and Commissions were invited to the Brandywine River Museum on March 29 for a number of presentations. No one was able to make this event.
